



Thank you for your interest in the Brooklyn Park Police Reserve. We believe you need a clear understanding of the police reserve and want to be certain you are not joining due to any misunderstandings.

The men and women who comprise this volunteer unit represent a wide range of age groups and careers. They are dedicated people willing to donate a portion of their time in order to be trained and ready when assistance is needed for the public's safety.

One of the primary functions of the reserve unit is to assist full-time police officers in performing community service tasks and to provide trained assistance during natural disasters and other emergencies. They are also called for backup assistance in details such as community sporting events, parades, school carnivals, dances and other special events that may require traffic direction and crowd control. In addition, they are requested by other nearby communities to offer assistance during similar situations and events.

Certain minimum requirements must be met before persons interested in joining the reserve program can be considered for membership. In order to qualify, the applicant **MUST**:

- Be at least 18 years of age
- Be a U. S. Citizen by birth or naturalization
- Possess a valid Minnesota drivers license and have a good driving record
- Have a high school diploma or equivalency certificate
- Be in good physical condition
- Have no felony conviction record/Have no domestic assault conviction record.
- Submit to a complete criminal history background check
- Have a telephone at your residence
- Have reliable transportation
- Pass an examination by an oral board of review

If you *clearly* understand the above, complete the application which will be reviewed by the Chief of the Brooklyn Park Police Department and the Reserve Chief. If accepted, you will be joining a specially trained organization, dedicated to the City of Brooklyn Park and proud to be a member of the Brooklyn Park Police Reserve.

**TENNESSEN WARNING**

Information requested on your application that is defined by State Statute as public may be released on request and includes job history, education and training, and work availability. Your name is private except when you are certified as eligible for appointment to a vacancy. Certain other information requested on your application is private and may be released only to you (MS15.165 Subd 2). Private data contained above:

- **NAME/SSN:** Used to identify you in relation to other applicants. You are legally required to provide your name, but not your SSN. Failure to provide this information may result in a delay in processing or rejection of your application.
- **LOCAL/PERMANENT ADDRESS/HOME TELEPHONE:** Used to contact you regarding your application's status. You are not legally required to provide this information. Failure to provide this information may result in a delay in processing or notifying you of your applicant's status.
- **LICENSE INFORMATION:** Used to certify applicants for positions where State law requires appropriate license. You are legally required to provide this information. Failure to provide this information may result in your rejection as an applicant for these positions.
- **AGE RANGE:** Used to accurately certify applicants for certain types of work according to State law. You are legally required to provide this information. Failure to provide this information may result in rejection of your application.
- **CITIZENSHIP STATUS:** Used to certify applicants for work in the US as determined by laws of the US Dept. of Labor and the State of Minnesota. Failure to provide this information may result in rejection of your application.
