# MOTION \_\_\_\_\_, SECOND \_\_\_\_\_, TO RECOMMEND TO CITY COUNCIL TO AUTHORIZE THE 2023 DEER MANAGEMENT PROGRAM AND APPROVE THE AGREEMENT WITH THE METRO BOWHUNTERS RESOURCE BASE TO CONDUCT THE 2023 HUNT.

#### **Overview:**

The Deer Management Plan identifies the numbers of deer within a range that the natural habitat can support effectively in the Brooklyn Park community. The plan recommends 15 to 20 deer per square mile which translates to 45 to 60 deer in the northern portion of the city, 15 to 20 deer along the Mississippi River south of Highway 610, and 15 to 20 in the Palmer Lake Nature Area. Since 2011, the City Council has supported a Deer Management Program consisting of a controlled archery deer hunt.

The Recreation and Parks Department works in partnership with Three Rivers Park District and a consortium of seven suburban communities to conduct an annual aerial survey. This survey provides a snapshot of the deer population within the Brooklyn Park community.

The City has contracted with the Metro Bowhunters Resource Base (MBRB) to conduct the controlled deer hunt. The MBRB coordinates and manages the hunter's application process, which includes a criminal background check and hunter orientation and skill evaluation. The controlled archery deer hunt occurs in the fall of each year. Here are the number of deer harvested each year from the past seven years:

#### Summary of 2022 Deer Hunt:

The first deer hunt period was very warm and saw limited deer movement, which equates to limited opportunities for hunters. The second hunt period saw temperatures in the 60's at midday, which is warmer than normal at the end of October which again attributed to less deer movement, and fewer deer being harvested. The third hunt period saw a snowstorm on the first day of the hunt, with lingering snow each of the following days. This led to less mobility of the deer population. A total of seven deer were harvested during the three hunting periods.

<u>Hunt locations to include:</u> Zone #1 – Northwoods Park Zone #5 – Palmer Lake Zone #10 - Greenhaven Park Zone #11 - Brookdale Park Open Space (Palmer Lake)

These properties are owned by either the City of Brooklyn Park or Three Rivers Park District. Due to preparation for upcoming construction, it has been decided not to conduct the hunt at the Environmental Nature Area and Mississippi Gateway Regional Park. The Banfill Island location was removed from the Deer Hunt in 2022.

#### 2023 Hunt Dates:

- October 2 & 3, October 4<sup>th</sup> would be reserved as a makeup date in case of inclement weather
- October 30 & 31, November 1st would be reserved as a makeup date in case of inclement weather
- November 13 & 14, November 15<sup>th</sup> would be reserved as a makeup date in case of inclement weather

One public safety benefit to controlling the deer population in an urban/suburban area is the reduction of deer related car accidents. Here is a look at the past five-year history of vehicle / deer accidents:

#### Primary Issues/Alternatives to Consider:

• Staff is recommending that the city continue to work in partnership with Three Rivers Park District to conduct the annual flyover and based on aerial survey results, authorize the Director of Recreation and Parks to enter into a contract with the Metro Bowhunters Resource Base (MBRB) to conduct the 2023 hunt, as the city has done since starting the Deer Management Program.

#### **Budgetary/Fiscal Issues:**

• The only cost incurred is for the shared cost for the annual fly over (approximately \$650) and the signs needed to mark the hunt areas and dates of the hunt for the public. The contractor, MBRB, does not charge for their services. There is a charge for certificates of insurance that the City provides to MBRB in the event they obtain access to private property.





# 2022 Deer/Vehicle Accidents









#### City Manager's Proposed Action:

MOTION \_\_\_\_\_, SECOND \_\_\_\_\_, TO WAIVE THE READING AND ADOPT RESOLUTION #2023-\_\_\_\_\_ TO AUTHORIZE THE CITY MANAGER TO ENTER INTO PROFESSIONAL SERVICE AGREEMENT WITH DESIGN BY MELO IN THE AMOUNT OF \$165,000 TO PROVIDE PRE-DESIGN AND DESIGN DEVELOPMENT FOR YOUTH AND TEEN RECREATION CENTER.

#### Overview:

As part of the 2018 Park Bond Referendum, funding was allocated for an additional teen recreation center. Since 2018, staff have explored partnership opportunities but have not been able to find a willing partner. In evaluating the current service needs in the area of Zanewood Recreation Center, the financial implications of staffing and operating another facility, and the concentration of young people in the area, staff recommends the construction of additional space at Zanewood in addition to renovations of existing space.

On December 29, 2022, a Request for Proposal was advertised in the Sun Post seeking a consultant for the planning services for a youth and teen recreation center. The planning services were divided into three phases:

- 1) Community engagement, concept planning, pre-design
- 2) Design development
- 3) Bid document preparation

A total of eight (8) proposals were received. A staff team reviewed proposals and scheduled interviews with four design firms: Design by Melo, Kodet Architectural Group, Locus Architecture, and LHB, Inc. A panel of nine Recreation and Parks staff interviewed the four finalists and selected Design by Melo based on their understanding of project scope, community engagement, experience, and proposed costs.

Due to the uncertainty of the final design, staff is recommending to award for Phase 1 and Phase 2 at this time. Once the design development is complete, phase three services will be re-evaluated for alignment with the project scope.

# **Budgetary/Fiscal Issues:**

- Funding for the Concept, Pre-Design Planning, and Design Development for the Youth and Teen Recreation Center is included in the \$26,000,000 Park Bond Referendum passed in November 2018.
- The Design by Melo total proposed cost for Phase 1 and Phase 2 is \$165,000.
- It is anticipated that Design by Melo would also provide the preparation of bid documents once design development is complete. An additional contract will be brought back to City Council for approval at a later date once the full scope of this work is determined.

#### **Overview:**

The Twins Ballpark sales tax, approved by the Minnesota Legislature in 2006, funds the Hennepin Youth Sports Program. State legislation authorizing the construction of Target Field allows Hennepin County to use a portion of the 0.15% sales tax surcharge to grant over \$2 million dollars each year to Hennepin County communities to assist with youth activities. A total of \$250,000 annually has been made available for playground grants.

Hennepin County is currently soliciting applications for the Youth Sport Playground Grant. The purpose of the playground grant is to build and improve playground structures throughout Hennepin County. Grant funds may be used for new playground construction, playground renovations or improvements. The awards are paid as reimbursement to the local government unit after the playground structure has been installed and paperwork showing payment has been submitted. Grants up to \$50,000 are available.

Staff have reviewed grant requirements and agree to be bound by Hennepin County Grant Agreement and are prepared to be the fiscal agent for the award, to disburse the funds, and ensure the funds are used as listed in the application.

#### Primary Issues/Alternatives to Consider:

Staff recommend authorization to submit application for the Hennepin Youth Sports Playground Grant.

#### Budgetary/Fiscal Issues:

Staff is requesting up to \$50,000 in Hennepin Youth Sports Playground Grant funds to be used to construct the playground at the west unit of Mississippi Gateway Regional Park.

#### City Manager's Proposed Action:

#### Overview:

Since 2015, the city has been working with the Three Rivers Park District (TRPD) on community engagement for the joint master planning of Mississippi Gateway Regional Park and Environmental Nature Area. The City owns the Environmental Nature Area along the west side of West River Road, while TRPD owns the parkland on the east side. In December 2020, the City Council authorized staff to enter into a cooperative agreement for both portions of the park to be designed, constructed, and operate as one cohesive park. Under the cooperative agreement, one of the prerequisites to beginning construction is the approval of the project budget by the Brooklyn Park City Council. At that time, the estimated budget was \$4.5M for the design development and construction for the west unit of the park. TRPD is responsible for entire cost of the east unit of the park in addition to the Maintenance Building and Rush Creek Regional Trail located on the western portion.

On February 16, 2023, the Mississippi Gateway Regional Park project was advertised to potential bidders. Bids were opened on March 16, 2023. H+U, as construction manager for the project, has estimated that TRPD owns 84.57% of the cost and the City of Brooklyn Park owns the remaining 15.43%. Based on this estimated breakdown of associated costs, the City of Brooklyn Park portion of construction is \$3,517,865 and TRPD portion is \$19,599,180. The City of Brooklyn Park portion includes a 5% contingency for unexpected costs associated with the project. The construction of the west unit of the park is expected to begin in 2023 and continue through 2024 with possible restoration in 2025.

In addition, the Mississippi Gateway Regional Park project is being considered for \$3M in state funding during the 2023 State of Minnesota Legislative session. This money would be allocated on a similar percentage to fund project alternates that cannot be funded at this time.

#### Budgetary/Fiscal Issues:

- The funding for this project is identified in the 2023-27 CIP #2027 from the Open Space, Land Acquisition and Development (OSLAD) Fund with \$2,800,000 in 2023 and \$1,020,000 in 2024.
- The City of Brooklyn Park has spent \$880,000 of the estimated \$4.5M total project cost on the planning and design for Mississippi Gateway Regional Park
- Payments will be made at various milestones to Three Rivers Park District as the project lead and holder of the construction contracts.

#### Weekly Adult Social Groups

Weekly social activity groups continue to renew 2023 yearly membership, with 146 people enrolled in one or more weekly activities. Members have access to 14 activity groups per week. Social activity groups include: several art/craft groups, cribbage, bingo, poker, Mah Jongh, 65 Rummy, 500 Cards, Dominoes, Scrabble, and a Book Club.

#### **Events**

The final Movie in the Dome showing was on Sunday, March 19<sup>th</sup> at 1pm. Folks enjoyed laying out on their blankets and while watching, "Soul".

Staff are in the process planning for the busy summer season. Upcoming events: Dog Park Awareness on May 23, Parade and Community Market on June 3rd, and Arts Festival on June 24.

There is also ongoing planning for Concerts which will be held Wednesdays after the farmers market from 6-7:30pm in the North Hennepin Community College courtyard.

#### **Farmers Market**

Vendor applications are now open for the 2023 market. Food and non-food vendors are welcome to apply. Staff are working with North Hennepin Community College to hold the market at the college parking lot off West Broadway this year. The goal is to increase visibility and access to the market.

#### Aquatics

Spring sessions of Aquatics classes kicked-off the week of April 3-7. Classes for the April-May sessions of swimming will be held at the Brooklyn Middle School pool. Classes include group, private & paired lessons, adaptive aquatics classes, adult lessons, and our new Women & Girls only swim class taking place on Monday evenings.

The New Women and Girls Only swim class is a time in the swim schedule that is exclusively reserved for women and girls with religious/cultural considerations or other factors that may require a woman only swim environment. The Women & Girls Only swim class is off to a fantastic start with a full class of participants all eager and thankful for the opportunity to learn to swim.

As the city is a proud recipient of the Minnesota Department of Education – Youth Water Safety Swim Grant, a swim scholarship fund has been created for those within our community who may have high barriers to

participation in lessons or at an increased risk of drowning. There are currently twelve families enrolled into the Spring swim offerings through the swim scholarship.

#### Adaptive Recreation/ Inclusion Services:

The Spring Sessions of Adaptive Recreation began the week of April 3 – 7. Program offerings include adaptive aquatics and adaptive fitness classes, as well as Reach for Resources Adaptive Recreation programs. Inclusion Services continue in a variety of recreation programs and services, including: K5 Fusion, Aquatics, Youth Sports, Dance, and Ice Skating.

The first of three Our Dance Place Spring Socials took place on Thursday, April 6 from 5:30 – 8:00pm at the CAC. This is a partnership program with a non-profit organization, Our Dance Place, that provides social events for people with disability- related needs. Staff welcomed 50 attendees, including Personal Caregivers, the first evening. Sponsors for the first social include Godfather's Pizza, Brooklyn Park Lions, and Brooklyn Park Police Department. With the sponsorships for this event was completely free for the community. The next two socials will take place on Thursday, May 4 and Thursday, June 1 from 5:30 – 8:00pm at the CAC.

On Tuesday, April 11, the City of Brooklyn Park Recreation & Parks Department was notified about receiving the Reach for Resources 2023 Community Partner of the Year Award. The city was nominated for demonstrating an unwavering commitment to enhancing the lives of people with disability-related needs and making significant contributions towards creating a more inclusive society through research, panels, resource fairs and advocacy for ADA accessibility. Staff are honored to receive this award and grateful for the partnership with Reach for Resources to provide inclusive programs and services for our community.

#### Dance

Dancers are getting into the full choreograph routine as they prepare for recitals coming up soon. Presale tickets started on April 10 with 1k tickets sold within the first day between the two recitals. Instructors are distributing costumes the week of April 10-13 leading into picture day on April 15.

Recitals will take place at Osseo Senior High School on Sunday May 7 at 3:00pm and 6:00pm.

#### Summer Camp

Summer Camp registration are closed with about 250 campers registered across all 4 sites. New efforts to be implemented this year are:

- Weekly guest readers during literacy exploration times
- Collaboration with community organizations for special events and projects
- Compost and recycling bins
- Archery program

Brooklyn Park Summer Camp was awarded a grant to support the start up of a new archery program and training for 2 staff from the Recreation and Parks Department.

# **Youth Sports**

Spring sports classes include soccer, basketball, and gymnastics along with Tiny Tots and Lil Tykes programs for children aged 2-4. Youth Sports classes are designed to be an introduction to sports and include athletic skill development along with social-emotional learning. Staff are working on developing a new partnership to expand tennis program offerings in the future.

#### Adult Sports

With the weather improving the indoor pickleball will be winding down as players transition to outdoor play at Norwood Park. Adult Softball team registration closed on April 9. League scheduling is in process. Softball begins on May 4 at Noble Sports Park. Cities Sports Connection (CSC) will begin their adult soccer leagues at the sports dome turf on April 24. Working with CSC provides Brooklyn Park residents the opportunity to join a highly reputable and fun soccer community.

# **Eidem Farm**

Recruiting for the Eidem Farm Specialist position has now closed, staff have reviewed applications, and interviews will be scheduled on April 17 and 18. This is a 29 hour a week part-time permanent position that had 15 applicants.

The annual Spring on the Farm event will be on Saturday, May 20 from 11 am – 2 pm. This event is the kick off to the warm season at the farm. Regular Open Gate hours will begin June 20.

#### Overview:

# 1. MISSISSIPPI GATEWAY REGIONAL PARK / ENVIRONMENTAL NATURE AREA <u>Funding Source(s):</u> OSLAD Fund

#### Project Update:

Development of the Brooklyn Park side of the park includes expansion of the off-leash dog area, relocation of the archery range, addition of a large picnic shelter and restroom facilities along with an expanded parking area is anticipated to begin in the spring of 2023.

The design development phase of the project is complete. Staff continue to review cost estimates and suggesting value engineering opportunities to manage the project budget. Staff is being challenged with the hyperinflation of the past 18 months. Some changes have been made to the planned shelter area on the west side of the park and prefabricated bathroom buildings are being planned to keep the project within budget.

The project was advertised for bid beginning February 16, 2023 with bids being due on March 16, 2023. Project contracts were awarded on March 30, 2023. Utility and initial construction is planned to begin during the summer of 2023. Staff have been working the project so that it will be phased now to allow the dog park to be used throughout most of the project. Construction will continue in 2024 and 2025 and a re-grand opening will be held in 2026. Construction is scheduled to begin on April 17, 2023.

#### 2. HOMETOWN BALLFIELD at Noble Sports Park (September 2022 – May 2023)

Funding Source(s): Park Bond Reinvestment Project

**Project Update:** The Hometown Ballfield project is moving forward. Staff worked with the architect from Bolton & Menk to secure proposals through the Sourcewell cooperative purchasing program to secure project proposals within budget. The project was approved at the July 11, 2022 City Council meeting. The city has approved and processed purchase orders to Upper Midwest Athletic Construction (UMAC) and SAAFE. UMAC will prepare all site work except bleachers and press box. SAAFE will construct the bleachers and the press box. Construction began September 15<sup>th</sup>, 2022.

Construction started the first week of October. Concrete for batting cages, dugouts and bleachers have been poured. Fence posts have been installed. Dugouts were installed in late March. Currently waiting bleachers to be delivered onsite to be installed. 2023 construction is resumed in late March, with completion expected in late May.

# 3. EAB UPDATE

Funding Source(s): Heritage Fund

Project Update: Work will continue in 2023.

# 4. NATURAL RESOURCE MANAGEMENT

Funding Source(s): Park Bond Reinvestment Project & Heritage Fund

**Project Update:** Staff continues reviewing priorities of the Natural Resource Management Plan. A Five-Year Priority Implementation Plan has been developed by working with Stantec. Work will continue in 2023 in key park areas.

# 5. COMMUNITY ACTIVITY CENTER IMPROVEMENTS

(2022 planning, 2023-2024 construction) <u>Funding Source(s):</u> Park Bond Reinvestment Projects

# COMMUNITY ACTIVITY CENTER

**<u>Project Overview:</u>** The plan is to improve the entrance to the facility, create an accessible customer service desk, update bathrooms, and create a welcoming and inviting community center for all customers.

**Project Update:** Staff engaged with 292 Design Group to update the 2018 aquatics feasibility study and develop the final strategy for the CAC improvements and what amenities should be included. Staff discussed funding strategies for the CAC improvements, Teen Center, Senior Center and Fire Stations at the July 25 2022 City Council meeting. The Council agreed that given the other priorities for fire station construction/remodeling and other financial commitments, an aquatic facility would not be part of the upcoming CAC improvements. Staff are working with the JLG/292 Design Group to evaluate the possibility of converting one ice arena into three basketball courts. A final concept design was provided to staff on January 3, 2023. JLG/292 Design Group provided cost estimates in the range of \$12 - \$15 million for the improvement to the CAC including Arena conversion to gym space. The City of Brooklyn Park has a \$5 million request for state bonding in the 2023 Legislative Session to support the improvements to the Community Activity Center.

# • SENIOR CENTER (2023 planning, 2023-2024 construction)

**Project Overview:** This improvement would add dedicated space for senior programming and adult fitness space. Final design and components will be developed when a final location is determined.

**Project Update:** The Senior Center is being considered with the CAC improvements and Fire Station projects. If a new Central Fire station is constructed on the site of the former Hennepin County Library, the current Central Fire Station could be remodeled into a new space dedicated to fitness and social activities for older adults.

# • TEEN CENTER (2022-23 planning, 2023-2024 construction)

**Project Overview:** The Zanewood Recreation Center has been a popular hub for youth services and recreation activities. The programming happening the space has outgrown the facility and additional program space is needed. Staff will work with a design consultant to determine if new space should be constructed, existing space should be renovated, or a combination of both.

**Project Update:** Zanewood staff have been meeting bi-weekly to discuss the mission, vision, goals, and amenities of the new Youth and Teen Recreation Center. The Zanewood staff has also met with Communications Manager to develop a strategic communication plan to inform the public about the project along with updates, pictures, and social media campaigns. On December 29, 2022, staff advertised a Request for Proposal for a design consultant to assist in the creation of a vision for a new Youth and Teen Recreation Center. Eight (8) proposals were received on January 26, 2023. Staff interviewed four consultants and have selected Design by Melo to lead the

community engagement, pre-design and design process. The project kickoff meeting was held April 6, 2023. The City of Brooklyn Park has submitted a \$4 million request for federal funding through Senator Klobuchar and Representative Phillips office to help support the Youth and Teen Recreation Center project.

# 6. HISTORIC EIDEM FARM INTERPRETIVE SIGNAGE DEVELOPMENT PLAN

**Funding Source(s):** Park Bond Reinvestment Projects

**Project Update:** Staff has engaged with Bluestem Heritage Group to help develop the design and signage language for each individual sign and kiosk. The design work for the signs and the kiosk are complete and quotes are being solicited for signage and kiosk fabrication. A separate plan will be prepared to obtain quotes to install the accessible paths and the concrete slabs for the signs to be surface mounted. The project is planned to be completed in June 2023.

# 7. CENTRAL PARK TENNIS COURT REHABILITATION

Funding Source(s): Heritage Fund

**Project Update:** The color coating of the court will be completed in the spring of 2023.

# 8. PLAYGROUND REPLACEMENT

Funding Source(s): Heritage Fund

**Project Update:** The replacement of Edinbrook, Sunny Acres & Lakeland Parks playgrounds was approved by City Council on December 12, 2022. Installation will take place in 2023 due to production and supply chain issues that delay equipment delivery. Staff will be using Auction Masters for the disposal process of the three parks for the first time. It is anticipated that the City Park playground will also be replaced in 2023 project.

9. HISTORIC EIDEM FARM VISITOR CENTER (2022 planning, 2023-24 construction) <u>Funding Source(s):</u> Park Bond Reinvestment Projects

**Project Update:** No new update at this time.

#### Overview:

#### 1. Violence Prevention Manager

The City of Brooklyn Park is currently hiring for a new position of Violence Prevention Manager. This position will coordinate the collaborative work between City of Brooklyn Park Departments (Police, Rec & Parks, Community Development, etc.) related to Reimagining Public Safety, other cities in the region experiencing similar issues (Brooklyn Center, Minneapolis, etc.), and the other governmental agencies (i.e. Hennepin County, school districts, hospitals, State of MN). First round of interviews are being conducted on Friday April 14 and second round of interviews will be April 21<sup>st</sup>. The new Violence Prevention Manager position is planned to start in mid-May.

#### 2. Reach for Resources Partner of the Year Award

The City of Brooklyn Park has been awarded the 2023 Partner of the Year Award from Reach for Resources. Reach for Resources is a partner with city staff in providing inclusion opportunities and events. Erin Bonikowske, Inclusion Specialist, is the lead staff collaborating with Reach for Resources and building a successful partnership.

#### 3. Farm Specialist

The Eidem Farm Specialist position received more than twenty applications for the position. Staff are reviewing applications and will be scheduling interviews in the coming weeks so a new person can be in place for the Spring on the Farm event on May 20<sup>th</sup>.

#### 4. Seasonal Staff Hiring

Staff are kicking off the busiest portion of the seasonal hiring process. Each year, Recreation & Parks hires approximately 200 seasonal employees and most of them are hired in the spring of each year. Staff are experiencing a slow hiring season again despite increasing pay rates for most positions.

#### 5. Project Funding

The City of Brooklyn Park has submitted a \$5 million request for state bonding in the 2023 Legislative Session to support the improvements to the Community Activity Center. In addition, Director Tullberg has submitted a \$4 million request for federal funding through Senator Klobuchar and Representative Phillips office to help support the Youth and Teen Recreation Center project.
